Description

Premium Energy Sill Sealer consists of an SBS modified asphalt adhesive base with a 6mm thick closed cell foam top which conforms to irregularities in the substrate to create a gasket under bottom plates, windows and doors. The closed cell foam top is non absorbent and compresses to form an air/moisture seal . Premium Energy Sill Sealer has an adhesive base however substrates must be primed with ProtectoWrap primer before installation to assist adhesion. Can be used under bottom plates as a DPC or under joinery openings to the sill area only. Available in two sizes; 88mm x 7.5m & 140mm x 7.5m

Scope of use

Can be used as a DPC under bottom plates and under joinery units to the sill area only. As Premium Energy Sill Sealer is highly compressible do not use packers when installing framing or joinery units to maximize benefits of air and moisture barrier control.

Conditions of use

Not to exposed for more than 4 weeks Ensure treated timbers have cured as per their respective SDS. Not compatible with sealants. Not to be applied over waterproofing membranes without consulting Marshall Innovations
